ENTRY REQUIREMENTS

1. All applicants must be **18 years** or over at commencement of the course.
2. The applicants first language is English; or the applicant has successfully completed an Australian Year 12 program; or successfully completed an English language course and achieve a language proficiency equivalent to IELTS 5.5 or higher; or hold an overall IELTS band score of at least 5.5 (Academic or General); or a TOEFL iBT test score between 46-59 or a score of 45 or higher in the Pearson Test of English.
3. Minimum completion of Year 12 in Australia and/or international equivalent.

- Provide a copy of your current passport (and a copy of your Australian Visa if you are already in Australia).
- Provide documentation of relevant qualifications as appropriate to the application (refer to Document Checklist).
- Provide proof of current level English (i.e. official test results **or arrange for an English Interview with Quality Training & Hospitality College (QTHC)**). Please refer to Document Checklist.

APPLICATION ASSESSMENT

- The Admissions team will assess each application and may request additional documents such as: Statement of Purpose, additional questions, financial documentations or any other information that may relate to your application.

OFFER

- Once QTHC has approved an application, the applicant is required to pay a non-refundable \$AUD150 application fee.
- After QTHC receives evidence of \$AUD150 application fee, the successful applicant will be issued with a Letter of Offer and their 1st semester invoice.
- Please ensure that the applicants understand the terms and conditions on the Letter of Offer and arrange **payment for the invoice**.

ACCEPTANCE

- Applicants understand, have read through all the details and signed the acceptance form.
- Return the form together with evidence of payment to QTHC.
- QTHC will issue the Confirmation of Enrolment (CoE) for your student visa application.
- Attend orientation session at commencement at Quality Training & Hospitality College.
